## **RECYCLING OUTREACH TEAM PROGRAM UPDATE**

Angelina Peone presented the program update.

For the month of May the Recycling Outreach Team had focused the messaging on International Compost Awareness Week (ICAW) which is an initiate by the Compost Research & Education Foundation. ICAW is celebrated during the first full week of May and the goal of the educational campaign is to raise public awareness about the benefits of using compost.

ICAW includes a poster contest. This year's theme is *Grow, Eat...COMPOST...Repeat*, recognizing the importance of composting in closed-loop sustainable systems that use compost to grow healthier food, support healthier soils and, ultimately, recycle nutrients back into the soil.

Governor Cuomo declared the week of May 6th-12the, New York State Compost Awareness Week in a proclamation in May 2018. Staff participated in the NYSAR3 Organics Council and the steering committee for NY ICAW efforts.

Angelina discussed the benefits of using compost.

- Compost is high in organic matter which has the unique ability to bind nutrients in soil reducing the need to use chemical fertilizers.
- Compost supplies beneficial soil microbes, which enhances soil biodiversity and helps to suppress plant disease pathogens and reduce the need to use harsh chemical fertilizers
- Compost improve soil water holding capacity, increasing soil water infiltration and permeability of heavy soils, which reduces runoff and erosion.
- Compost has the unique ability to buffer or stabilize soil pH, which improves nutrient availability for a range of plant species.
- Compost improves soil structure, porosity, and density, allowing room for water and air to enter micro pore spaces in soil, creating a healthier plant root environment.
- Compost makes any soil easier to work and cultivate

In addition to the above horticultural benefits, composting plays an essential role in meeting zero waste goals. Composting reduces the dependence on landfills, lowering harmful greenhouse gas emissions and is an effective and beneficial way of managing the organic materials that make up 30% of the waste stream.

Since 2012, to date, the UCRRA Organics Recovery Facility has managed more than 19,000 tons (19,430) of source separated organics that, if landfilled, would have traveled a cumulative 266,481 miles for disposal. These long haul trips avoided by composting this material are the equivalent of driving 10.6 trips around the Earth. To date,

2012-May 2021, the total CO2 emissions avoided from both transportation and landfill disposal of these organics is calculated to be more than about 32,000 metric tons of carbon dioxide. (32,111.71 tons of CO2)

The total CO2 emissions avoided is equivalent to the CO2 emissions from:

- burning 35,492,543 pounds of coal or consuming 74,345 barrels of oil
- or 5,833 homes' electricity use for one year
- or the GHG emissions avoided by 6.7 Wind turbines running for a year
- or the carbon sequestered by 39,343 acres of U.S. forests in one year

Composting is a climate smart solution, and UCRRA's composting program is a community asset that fosters stewardship of Ulster County's environment and natural resources. Celebrating ICAW, the Recycling Outreach Team:

- Kicked off May with the Compost Bin and Rain Barrel Sale;
- Spring Classes about composting;
- Social media promotions all month long in English and Spanish;
- Four ads in the Daily Freeman promoting our partners in composting program (attached to board update);
- Prepared a Blog post;
- Mailed information letter to County Executive and the Secretary of the Legislature on May 5th about ICAW and UCRRA educational resources;
- Is scheduled for two public speaking engagements in June to promote the Partners in Composting program; and
- Is scheduled to record a new PSA encouraging businesses to participate in composting and the PSA will air on Radio Kingston.

## **GENERAL REPORTS**

#### FINANCIAL MATTERS

Tim DeGraff presented the April 2021 Treasurer's Reports and MRF Cost Center Analysis.

#### **Treasurer's Report**

For the month of April the Agency's MSW tons were 8,723 and C&D tons were 4,120. No Revenue line items of note. Total revenue for the month was \$1,586,302. Expense line items of note: Personnel Expense line in the amount of \$329,517 due to three payrolls, Composting Operations in the amount of \$15,974 related to grinder repairs. Total operating expenses for the month were \$1,407,542. Net operating revenue was \$178,760. Capital outlay of \$56,410 related to the compost expansion. For the month of April, the fund balance was \$122,350. Year-to-date deficit of \$1,092,098.

#### **MRF Cost Center Analysis**

Net revenue of \$56,914. Total personnel expenses were \$54,240. Total operating expenses were \$8,172. Total personnel/operating costs were \$62,412. Net loss for the month of \$5,498. Year-to-date net loss of \$28,954.
