Ulster County Resource Recovery Agency joins municipalities across New York State who are combating the negative environmental and economic effects of *contaminated recycling*. In fact, this issue is so widespread that a statewide education campaign, known as Recycle Right NY, was created to help municipal recycling programs educate residents about the importance of recycling correctly.

This informative memo is notifying you that, according to our records, the contamination rate of the material collected from your Municipal Recycling Drop Off Center was X.XX % in 2023 (X.XX TONS). Thank you for demonstrating such a commitment to 'keeping the recycling stream clean'! How does this compare to other local recycling programs? The average among all the local Town Transfer Stations was 1.55 % with the highest rate being 7.61 %. No level of contamination is ever ideal, but we recognize that some contamination is always inevitable. As a reminder, our Recycling Outreach Team is always available to answer questions regarding recycling, work with you to obtain operational efficiencies and assist in recycling grant initiatives.

Contamination not only ruins the value of recyclables, sometimes rendering them completely unmarketable, but it can also seriously damage our equipment and harm sanitation workers. For years, the solid waste industry ranked among the top five most dangerous occupations in the nation, partly due to the wrong items being placed in recycling bins.

As we start a new year, I'd like to take this opportunity to recognize the important role that municipal recycling programs can play in improving the quality of the valuable recycling commodities processed by the Agency. We need all our community partners to feel a shared responsibility to educating residents about basic recycling guidelines and standards, which has a direct result in the efficiency, efficacy, costs, and long-term sustainability our Ulster County's recycling program. In recognizing the challenges of educating the public about what is recyclable, our Recycling Outreach Team can support your municipal recycling programs in several ways, including:

- ✓ Provide technical support, like sharing information about grant opportunities, and make recommendations to expand Town Transfer Station services.
- ✓ Provide reference lists of recycling vendors for clothing/textile recycling, electronics recycling, scrap metal recycling, paint recycling, Repair Cafes, Reuse organizations, local composting options, and more.
- ✓ Provide free copies of our <u>Dual Stream Recycling Guide</u> (available in English and Spanish). Please link to this on your Town website and distribute with every facility permit in the new year!
- ✓ Collaborate with your Town to host a free public workshop about recycling.
- ✓ Host an educational outreach table at your Transfer Station to distribute flyers and answer recycling questions.
- ✓ Discuss recycling questions with your residents through our Recycling Hotline, which is staffed Monday Friday from 7:30-3:30 Hotline: 845-336-3336
- ✓ Facilitate a month-long educational display at your Town Hall or community center to showcase how to "Repair Recycling Habits"
- ✓ Provide free recycling signage that highlights the Do's and Don'ts of recycling (project completed in 2023).
- ✓ And more! This is not a complete list.

Our Recycling Outreach Team periodically hosts MRDC Informational Meetings to further provide opportunities for professional development about recycling. At our last meeting, a guest speaker from Habitat for Humanity presented a partnership opportunity to facilitate reuse programs. At our next meeting later this year, we will focus on how Towns can partner with Paint Care NY to facilitate free paint recycling programs. Beyond the regulated recyclables, Towns also play an essential role in advancing the County's aggressive waste reduction goals.

With your help, we can "clean the stream" and make the recycling industry safer, more economical and more resilient than ever. I invite you to visit Recycle Right NY to learn more and to take advantage of the opportunities that our Recycling Outreach Team offers. Please share this letter with your Town Transfer Station managers and please feel free to reach me if you have any questions about this informative letter.
