JANUARY 25, 2024**

The Ulster County Resource Recovery Agency held an Annual Organizational Board Meeting on January 25, 2024.

The proceedings were convened at 6:00 PM by who was Chair prior to election of officers.

PLEDGE OF ALLEGIANCE

ELECTION OF OFFICERS

CHAIR

Andrew Ghiorse nominated **Regis Obijiski** as **Chair** and it was seconded by **James Gordon**. 5 in favor, 0 opposed.

Andrew Ghiorse handed his position over to Regis Obijiski. He stated he was stepping down due to medical issues. The Board thanked him for his work as Chair.

VICE CHAIR

Andrew Ghiorse nominated **James Gordon** as **Vice Chair** and it was seconded by **Regis Obijiski**. 5 in favor, 0 opposed.

TREASURER

Andrew Ghiorse nominated **Regis Obijiski** as **Treasurer** and it was seconded by **James Gordon**. 5 in favor, 0 opposed.

Regis Obijiski stated if someone else was interested he would introduce some of the concepts of being the Treasurer.

SECRETARY

Regis Obijiski made a motion that **Kenneth Gilligan** be nominated to serve as **Secretary**. **Andrew Ghiorse** moved the motion, and it was seconded by **James Gordon**. 5 in favor, 0 opposed.

ESTABLISH REGULAR MONTHLY BOARD MEETING DATE AND TIME

James Gordon made a motion to establish a regular monthly Board meeting date to be set for the fourth Thursday of each month at 6:00 PM; and it was seconded by Andrew Ghiorse. 5 in favor, 0 opposed.

APPOINTMENT OF BOARD COMMITTEE MEMBERS- The Board agreed to the following appointments:

Audit Committee: Regis Obijiski will be Chair of the Audit Committee and Members will be Andrew Ghiorse and Donna Egan.

Finance Committee: Regis Obijiski will be Chair of the Finance Committee and Members will be David Gilmour and Donna Egan.

Governance Committee: James Gordon will be Chair of the Governance Committee and Members will be Andrew Ghiorse and David Gilmour.

Zero Waste Committee: Donna Egan will be Chair and Members included the whole Board. David Gilmour made a motion to include the Board as a whole, in the Zero Waste Committee. VOTE: 5 in favor; 0 opposed.

Recycling Oversight Committee: Donna Egan will be the Committee Member

DISCUSSION

Andrew Ghiorse announced to the Board and staff that he was stepping down and resigning as the representative for the Legislative Reform Committee due to medical issues.

James Gordon moved to accept Andrew Ghiorse's resignation, and it was seconded by Regis Obijiski. 5 in favor, 0 opposed.

Regis Obijiski appointed James Gordon as the representative to the Reform Committee.



*The minutes were amended to correct Laura Petit's title from Ulster County Legislator to Chair of the Recycling Oversight Committee and member of the Reform Committee


The Minutes were approved by the Board.
