Did you know that **freon appliances** like **refrigerators**, **freezers**, **dehumidifiers**, and **air conditioners** may contain chemicals that are harmful to the ozone layer and can be very powerful greenhouse gases?

What is Freon?

"Freon" is a trademark name that has been used to refer to several different **refrigerants**, including chlorofluorocarbons (CFCs*) ex. *CFC-12*, hydrochlorofluorocarbons (HCFCs*) ex. *HCFC-22*, which is often referred to as "*R*-*22*," and hydrofluorocarbons (HFCs).

Why are Refrigerants Harmful?

Refrigerants are typically emitted in small quantities, but because they are potent greenhouse gases, they are also referred to as **High Global Warming Potential Gases**. HFCs have **1,000 to' 9,000** <u>times the capacity to warm the atmosphere than carbon</u> <u>dioxide</u>. The release of refrigerants into the environment during production, leakages in existing appliances/equipment, and improper end-of-life disposal of appliances all contribute to **climate change**².

*CFCs are ozone-depleting substances and have been phased out under the *Montreal Protocol* and HCFCs are currently being phased out.

Refrigerant-Containing Appliance Disposal Guide

Refrigerant-containing appliances must be properly disposed of at end of life to ensure the refrigerants are properly recovered and reclaimed or destroyed.

Town Transfer Stations

Many <u>Town Transfer Stations</u> (also known as *Municipal Recycling Drop Centers*) accept hard-to-recycle items, like Freon appliances.

Access to these services can require purchasing an annual permit for a fee. <u>Please contact your local transfer</u> <u>station</u> to verify hours, fees, and accepted items before visiting.
