

## INTRODUCTION

---

The Ulster County Resource Recovery Agency (UCRRA) is the solid waste planning unit for the County of Ulster and is responsible for maintaining and updating a Local Solid Waste Management Plan (LSWMP). The LSWMP includes requirements for collecting waste characterization data on an annual basis for evaluative and long term planning purposes.

The UCRRA administers an **Annual Waste and Recycling Report Survey** to collect and analyze metrics from “large waste generators” within the County or those who accept solid waste or recyclables generated from within the planning unit. These efforts are helpful for creating a more comprehensive understanding of the total waste stream and the management of various wastes, including regulated recyclables. The data collected can be useful to broadly estimate total waste generation, diversion rates, and recycling or composting rates.

The hundreds of large waste generators surveyed represent various business sectors including but not limited to: grocery stores, retail outlets, scrap metal recovery facilities, waste and recycling haulers, municipal recycling drop off centers, educational institutions, healthcare facilities, and other specialized large waste generators.

**The information presented in this document represents both scale weight data (if available) and weight estimates based on survey responses. Please note that these survey responses are self-reported and unverified in most cases. It should be noted that the contact list for this report and the total number of surveys collected may vary significantly from year to year. The methods used by respondents for measuring or estimating total weights and volumes, and other limitations, may contribute to inaccuracy or incompleteness of this dataset. Therefore, the Agency acknowledges that this report should not be used or represented without acknowledging these limitations with great consideration, and that the information presented should not be used out of context in any part of subpart of this report.**

Based on survey results, the total waste stream generated in Ulster County is estimated to be **293,397 tons**, including municipal solid waste (MSW), construction and demolition debris (C&D), biosolids, regulated recyclable materials, organics, scrap metal, electronics, hazardous wastes, and various other waste subcategories. Of the **293,397 tons** of all waste, **116,155 tons** was diverted from landfill disposal through various recycling and composting efforts. **Based on these survey results, it can be inferred that Ulster County had a 40% Diversion Rate in 2024.**

**Note: This includes both residential and commercial waste sources.**

UCRRA managed approximately **104,462 tons** of municipal solid waste (MSW). Additionally, commercial and residential programs recovered **28,507 tons** of regulated recyclable materials (plastic bottles, jars, jugs, tubs, metal cans, paper, cardboard, glass and other beverage containers). Of the **28,507 tons** of recyclables, **13,374 tons** were reported as mixed single stream, or unsorted recyclables. The remaining recyclables were collected using various levels of source separation. Of the **28,507 tons** of total recyclables, approximately **11,288 tons** was source separated corrugated cardboard, largely from commercial sources, making up the second largest material component of the total recycling stream measured by the survey responses. Mixed paper was the third largest category of this recycling stream measured, at **2,523 tons**. **Based on these survey results, it can be inferred that Ulster County had an estimated 21% Recycling Rate in 2024, when measured against the municipal solid waste only.** **Note: This includes residential and commercial sources combined. The recycling rate equals the quotient of all regulated recyclable materials measured, and the sum of all municipal solid waste (MSW) plus all regulated recyclable materials measured.**

In addition to regulated recycling, **21,486 tons** of organic materials were managed by composting, animal feeding operations, oil/fats rendering, anaerobic digestion, or through food

donation initiatives. Of the **21,486 tons** of organic materials documented by the survey, **6,770 tons** were source separated food scraps, making up the largest component of this organics recovery category, though a fraction of this material is understood to be generated out of county. Yard wastes represented the next largest category, at **4,847 tons** (brush, tree trunks, grass clippings, etc.). Distinctly within this organics recovery category, UCRRRA diverted **3,258 tons** of biosolids to a composting operation, representing the third largest component of all organics recycling measured. **Based on these survey results, it can be inferred that Ulster County had a 17% Composting Rate in 2024. Note: This does NOT include residential participation in backyard composting or community gardens, which is not measured by this survey. The composting rate is calculated as the quotient of all organics recycling measured, and the sum of all municipal solid waste plus all organics recycling measured.**

When recycling and composting are combined, which is very common and useful in solid waste analytics, this results in a **32% total recycling and composting rate**. Note: The total recycling and composting rate is calculated as the quotient of the sum of all regulated recycling and organics recycling measured, with the sum of all municipal solid waste plus all regulated recycling and organics recycling measured.

**Of the 293,397 tons of waste that were measured by the survey, the Ulster County Resource Recovery Agency managed 160,046 tons of materials, or 55% of the total waste stream recorded by this report.**

Approximately two hundred and seventy three (**273**) unique facilities received requests to complete the 2023 Annual Waste & Recycling Report. It should be noted that often, a single point of contact represents multiple facilities (example: School Districts, Grocery Store Chains, etc.). Entities surveyed represent various sectors including grocery stores, retail outlets, scrap metal recovery facilities, waste and recycling haulers, municipal recycling drop off centers, educational institutions, healthcare facilities, and other large waste generators. The contact list for this report may vary significantly from year to year as new contacts may be added, removed, or re-categorized for various reasons.

A standard memo with detailed instructions was sent to all recipients. The memo included volume to weight conversion factors for every type of waste listed, which standardized methods for estimating weights when exact tonnages were unknown. It should be noted that the weights reported are unverified, self-reported tonnages.

Emailed notices were sent and tracked electronically via a Google Mail Merge system beginning January 3<sup>rd</sup> 2025. Where necessary, notices were also sent via fax or direct mailings to physical addresses if email addresses were not available. Extensive efforts were made by the UCRRA to collect completed forms.

Additional emailed notices were sent at the end of January, mid and end of February 2025 to all contacts that hadn't responded. Near the deadline, staff also followed by direct phone calls to ensure communications were reaching the appropriate contacts. Despite these efforts, the Agency recognizes the data presented is limited by response rate and accuracy of data.

As reports were received, the Director of Sustainability tracked responses in a master contact list, then entered responses into an Excel database organized by generator type subcategories (Retail, Education, Hospital, etc.). For each entry in the database, the generator name and location were recorded, along with the types of material(s) reported, the tonnage of each material reported, and the final disposal/recycling destination for each material reported. The list of material types is standardized on all spreadsheet tabs, which supports the final calculations.

A totals column sums all entries within each material type category, representing the total waste generation within that generator type (example: total tons cardboard from all Retail Stores). Then, an adjusted total is calculated to eliminate double-counting tonnages from other generator types. This is necessary because the weights reported by the end-recycler should always supersede other entries that referenced a particular destination (example: total tonnage reported by the hauler is preferred over adding up the sum of all tonnages reported by all their customers). The data submitted by the end-recycler is typically a more reliable number. For database

management, any entries that would be included towards the adjusted total were left as black-colored text in the database, while entries that would be backed out (subtracted) from the total calculations were marked as red-colored text so they could be easily identified and subtracted. Simple Excel functions were used to calculate totals within each generator type. Then, totals were transferred to an Executive Summary, which represented all of the adjusted totals from the entire workbook, ensuring nothing was counted twice. It should be noted that these summaries by sector do not represent total waste generation by sector and are only useful for the purpose of not double counting any of the wastes captured in the survey analysis.

For the purpose of this report:

Waste Generation = Total sum of all waste streams reported

Diversion rate =

$$\frac{\text{Total sum of waste that was recovered for the purpose of reuse or recycling}}{\text{Total Waste Generation}}$$

Recycling rate =

$$\frac{\text{Sum of all regulated recyclable materials reported}}{\text{Total Municipal Solid Waste stream} + \text{regulated recyclable materials reported}}$$

Recycling & Composting rate =

$$\frac{\text{Sum of all regulated recyclable materials and organics reported}}{\text{Total Municipal Solid Waste stream} + \text{regulated recyclable materials} + \text{organic materials reported}}$$

## 3. RESPONSE RATE

---

Of the three hundred facilities contacted, the total overall response rate in 2024 was sixty-one percent (61%); a total of one hundred and eighty three facility reports were received. The response rates for each generator type (tabulated below) should be considered when interpreting the survey results. The Agency can seek to improve response rates in the future by committing more compliance-related resources and staff to these annual reporting efforts, noting that failure to report is considered an unlawful act per local law.

## 4. ASSUMPTIONS

---

***The facilitator of this report emphasizes the following assumptions about these survey results:***

1. The survey responses represent the waste characterization of the facilities being surveyed, to the best of the ability of the persons completing the reports.
2. The information presented in this document demonstrates both scale weight data (if available) and estimates. There are limitations to the accuracy of this data including the total number of facilities surveyed, which varies from year to year; the response rate for each generator type category; methods used by respondents for measuring or estimating total weights and volumes; and other limitations that may contribute to inaccuracy or incompleteness of the dataset.
3. Volume to weight conversion factors were provided in a memo, were consistently utilized to the greatest extent, and the conversion factors are believed to be accurate based on available data.
4. Low response rates lead to data gaps that should be considered when interpreting these survey results. Response rate may be due to various factors (emails bounce/junk, outdated contacts, effect of new facilities added each year, etc.)
5. This report cannot represent additional waste generators that the Agency has not yet identified or successfully surveyed.
6. The Agency surveyed some businesses located outside of Ulster County in cases where recyclables were transported to their facilities. The intent of the survey (to represent Ulster County waste only) was clearly communicated, though in some cases, it may not have been possible to subtract out-of-county data as a small fraction of the number they reported.

**Therefore, the data presented in this report should not be represented without acknowledging these limitations and recommends that the information presented should not be used out of context in any subpart of this report.**






