Recycling Compliance Report

April 2026

- I spent a lot of time assisting Angelina with gaining compliance with the Annual Recycling Reports. I sent final notice emails to businesses that have failed to complete the report which resulted in many businesses complying. I am now going to each business (50) that has not complied with the law by completing the report. Many of the businesses I have visited have new store managers with new contact information and have not received our correspondence. I will have an update next month about my success in going to the businesses.
- Sonny Zito has been coming into our facilities on Monday's and Thursday's every week. I had noticed that on Monday's they were bringing in less than a half ton every week, so I began to monitor their truck after leaving our facility and found that they were picking up MSW and recycling in Ulster County not following the Mandatory Source Separation and Recycling Law and also bringing the trash into Orange County. I documented this for two weeks before confronting them with the evidence I had, and for the last 3 weeks they have been bringing in over two tons every Monday which is a big jump. I will continue to monitor this situation to make sure they are following the laws.

- **American Printing finished the Inspection sheets I had requested. I will begin using them this month. Once my inspection is complete the driver will receive a copy, the agency will keep a copy, and at the end of each week I will send copies out the hauler's along with a contamination % for the week.**
- **After discovering two haulers last month operating in the Saugerties area, I did some investigating and found that the Ace Carting truck is being operated by County Waste. The truck is coming into our facilities with all the MSW.**
- **I am still investigating A & B Carting. I have not been able to determine if they have any accounts yet. They have just been advertising on the Saugerties Facebook page. I have called and left a message but have not received a call back yet.**
- **I attended the Recycling Oversight Committee meeting.**
- **The following properties have implemented recycling**
 - **48 sunny Acres**
 - **131 Western Ave**
 - **1-12 Costello Drive**
 - **37 Church St**
 - **276-300 Fosler Rd**
- **I have been conducting inspections of town parks and with the nice weather approaching I will make it a priority this month to try and get recycling implemented at all parks in the county.**

- **I continue to monitor and document evidence of haulers not complying with the Flow Control Law and the Mandatory Source Separation Law. I have evidence documented and ready once the Administrative Law Judge is appointed.**
