Recycling Compliance Report

May 2026

- I traveled around the County to businesses that have failed to complete the mandatory Annual Recycling Reports. I had the opportunity to meet with managers and supervisors to discuss the requirements and importance of the Annual Recycling Reports. Out of the 50 businesses I went to, approximately 20 submitted their reports to the agency. Many of the managers I met with assured me that the report would be submitted but failed to complete it. I issued each manager a copy of the law and Scan code that directed them right to the digital report for easy completion.
- I continued to monitor Sonny Zito to make sure they were sticking to the agreed upon plan to remain in compliance with the Flow Control Law. They are continuing to bring in all MSW to our facilities.
- Rieber Carting, who is a newly approved hauler in Ulster County, has begun to expand and I have found them to be in violation of the Mandatory Source Separation and Recycling Law already. I have a meeting scheduled to sit down and discuss a plan to ensure they remain in compliance.
- American Carting who is a newly approved hauler operating out of Orange County is in violation of the Mandatory Source Separation and Recycling Law as they have an

apartment complex in Plattekill that does not have recycling being offered to the tenants. I reached out to the complex and they were very upset they were not informed that recycling is mandatory In Ulster County when they subscribed. I will be meeting with American Carting to make sure they understand the laws of Ulster County and abide by them.

- **A&B Carting is operating out of Poughkeepsie; NY and they are promoting on Facebook that they are offering residential pick up in Ulster County. They have posted videos and posts that they are picking up in Ulster County on Thursdays. I have left a voicemail, and I am currently awaiting a response.**
- **I issued Mandatory Source Separation and Recycling noncompliance letters to

- **I continue to monitor and document evidence of haulers not complying with the Flow Control Law and the Mandatory Source Separation Law. I have evidence documented and ready once the Administrative Law Judge is appointed.**
