WHEREAS, the Agency requires a new Caterpillar Skid Steer Loader (Exhibit A) model 270 year 2027 (the "Equipment") to replace the S850 Model (2015), to perform the work required to carry out the duties of Solid Waste Management, and

WHEREAS, the Agency staff has recommended the purchase of the Equipment through the Sourcewell Statewide Contract in compliance with the New York State bidding as the Agency is allowed to piggyback under New York State General Municipal Law Section 103; (see attached Exhibit A describing the Equipment to be purchased), and

WHEREAS, the purchase of said Equipment was approved in the 2025 Budget, however due to financial resources, Agency staff recommend the purchase of the Equipment be a 2026 purchase, and

NOW, THEREFORE, BE IT

RESOLVED, that the Ulster County Resource Recovery Agency does hereby authorize and approve the purchase of the Equipment as described in the attached documents, and be it
